### INFORMATION ON THE COURT OF JUSTICE OF THE EUROPEAN COMMUNITIES

#### I. INFORMATION ON CURRENT MATTERS—FOR GENERAL USE

#### A. Hearings of the Court

Hearings of the Court comprise a calendar of public hearings, drawn up on a weekly basis. It is, however, sometimes necessary subsequently to change dates. The Hearings of the Court in French may be ordered from the Registry of the Court free of charge. (This calendar, which is only a guide, is hardly of any use to anyone residing in the United States.)

## B. Proceedings of the Court of Justice of the European Communities

The Proceedings of the Court of Justice of the European Communities is a weekly summary of the judicial work of the Court, appearing in the six official languages of the Community. It can be ordered free of charge from the Press and Legal Information Service in the language desired. Orders in the United States may be placed through the Washington or New York Information Offices of the Community, at the addresses below or directly with the Legal Information Service of the Court.

# C. The Judgments, Orders of the Court, Reports of the Hearings, Opinions of the Advocates-General

The Judgments, Orders of the Court, Reports for the Hearings, and Opinions of the Advocates-General are sent in the form of roneoed documents free of charge to the parties and may be sent, on express request, to other interested persons once they have been delivered or lodged at the public hearing. Orders may be placed with the Registry for: Judgments, Orders, Reports for the Hear-

ings; Opinions of the Advocates-General may be ordered from the Press and Legal Information Service. (The London Times carries, since May 1972, European Law Reports on leading cases decided by the Court.)

#### II. INFORMATION AND TECHNICAL DOCUMENTATION

## A. Information on the Court of Justice of the European Communities

Information on the Court of Justice of the European Communities is a quarterly bulletin published by the Publications Division, Directorate-General of Information, Commission of the European Communities, Brussels. It contains headnotes and short summaries of leading cases before the European and National Courts. This bulletin, free of charge, can be ordered from the Information Offices of the Community, whose addresses appear below.

#### B. Annual Synopsis of the Work of the Court

The Annual Synopsis of the Work of the Court, which is free of charge and in six official languages, can be ordered from the Washington or New York Information offices.

## C. Collection of Texts on the Organization, Powers and Procedures of the Court

The 1967 edition of the Collection of Texts on the Organization, Powers and Procedures of the Court is completely out of print. A new edition is available in Official Journal L350, December 1974 for \$1.00. Orders are to be placed, with an indication of the language desired, with the Publications Office of the European Communities or the bookshops whose addresses are set out below.

#### III. OFFICIAL PUBLICATION

Of course, the *Recueil de la jurisprudence de la Cour* remains the only authentic source for citing the case law of the Court of Justice. This *Recueil*, covering twenty years of case law (1953-1973), is on

sale at the same addresses as the publications mentioned under heading II above. As from 1973, the *Recueil* is also published in English under the heading "Reports of Cases before the Court." The volumes for the years 1953 to 1972 are in the process of being translated into English.

#### IV. VISITS

The Court sits in public hearings on Tuesdays, Wednesdays and Fridays, except during the legal holidays (20 December—6 January, one week before and one week after Easter, 15 July—15 September. Please also see below for the complete list of national, religious or bank holidays in Luxembourg).

Visitors are admitted to public hearings of the full court and of the panels, according to the capacity of the room. No visitors are admitted to private hearings or chambers.

About one-half hour before the beginning of a public hearing, a briefing will be delivered to groups of visitors who have announced their intention to come to the hearing in advance.
